- 7. Discussion, consideration, and action regarding the monthly financial reports and cash reconciliations. David Harris (D2) motioned to approve the monthly financial reports as presented. Lawrence Padalecki, Jr (D12) seconded the motion. The motion carried with 8-Aye and 0-Ney.
- 8. Discussion, consideration, and action regarding the Purchasing Policy. John True (D11) motioned to approve the Purchasing Policy as presented. Howard Dalros (D5) seconded the motion. The motion carried with 8-Aye and 0-Ney.
- 9. Discussion, consideration, and action regarding the reimbursement to BCESD5 for cost and expenses for the creation of the Association. David Harris (D2) made a motion to reimburse Bexar County ESD No. 5 for their legal fees in regards to the creation of the Association upon verification of proof of expenditures and payment from ESD5. Christopher Herrera from the Fire Marshal's Office will bring a representative from Bexar County Purchasing to speak about the Bexar County Purchasing Interlocal Agreement Program established with other government partners. The Association did not take action on item 10.
- 11. Discussion, consideration, and action regarding Bexar County's support of the ESDs for removal of debt limits imposed but the City of San Antonio and other items related thereto. Rudy Rodriguez provided information and updates regarding Bexar County's support for ESDs to remove debt limits imposed by the City of San Antonio and the County's next action to be taken. The Association did not take action on item 11.
- 12. Discussion, consideration, and action regarding legislative matters, including but not limited to the Texas 2023 legislative session and any other related matters.
